

Government:


- Educate and encourage business

Consumer organizations


Oversight and education





Business Role

- A business needs to understand how it uses information in a manner that creates value while being compliant with privacy laws and expectations
- This understanding leads to thoughtful, complete, and understandable communication
- The APEC Privacy Framework requires companies to give privacy notices to individuals
 - Those privacy notices need to be complete
 - Easy to read






Research Defines the Problem

Research tells us:

- Notices must be relatively short
 - No more than seven topics
- They must be in plain language
 - No jargon
- In a common format that makes it easy for the consumer to understand and compare
- Long detailed notices don't meet those needs






The Solution

A system of notices


- A very short notice when collecting information with a mobile phone or PDA
- A condensed notice in a common template format for most uses
- A complete notice, on request, with all the details
- Multi-layered notices are the solution





International Standard


- Multi-Layered Notices is concept that is being adopted and recognized around the World
- Meets the requirements of the APEC Privacy Framework and the OECD Guidelines
- The European Union working party on privacy adopted a common position on multi-layered notices
- The international data protection commissioners endorsed the concept of condensed notices





Multi-Layered Notice History


- The Center for Information Policy Leadership began work on this concept in 2001
- International data protection commissioners endorsed the basic concept in 2003
- Berlin Memorandum explored the consensus in 2004
- EU Common position 2004
- US financial services regulator began detailed research in 2005






Short Notice


- For use where data is collected and space is limited
- Informs the consumer about:
 - The company that has collected the data
 - Primary use
 - How to get more information

Condensed Notice

Common template with six critical elements

- 1. The party covered by the notice
- 2. Data collected from and about the consumer
- 3. Uses (purposes) and sharing
- 4. Individual choices and how to make them
- 5. Other, important information
- 6. How to contact the organization








Ten Steps to A Complaint Notice

- 1. Map data process
- 2. Review laws
- 3. Write internal policy
- 4. Translate internal policies into complete external policy
- 5. Test the language

- 6. Capture the key elements in condensed notice
- 7. Revise complete notices so the order is the same as condensed notice
- 8. If the business collects data via PDAs develop short notice
- 9. Conduct final test
- 10. Publish
