

推廣宣傳一向是公署工作的主要一環,希望 能夠藉此提高市民在保障個人資料私隱方面 的意識。在過去數年,公署的推廣工作主要 集中在機構方面,以確保它們的行事方式符 合私隱條例的規定。「保障資料主任聯會」的 成立,為公署及各資料使用者提供了一道溝 通橋樑,讓雙方可以分享及交流保障個人資 料的意見及經驗。

公署亦明白,在社區推廣尊重彼此私隱的文 化,讓市民認識到這是他們的社會責任,也 是非常重要的。為了達到這個目標,公署決 定致力推行公眾教育來協助年青人建立正面 的社會價值觀。

Promotion has always been one of the PCO's major tasks in raising awareness of personal data privacy protection within the community. In the past few years, promotional efforts have focused on organizations to ensure compliance with the PD(P)O. The establishment of the Data Protection Officers' Club has also provided a platform for a dialogue between the PCO and data users enabling them to share views and exchange work experiences on matters relating to personal data protection.

The PCO also recognizes the importance of promoting a culture within the community where respect for an individual's privacy is the social responsibility of each and every citizen. In seeking to achieve this goal, public education directed towards the younger generation plays a vital role in shaping the future values of society.



Privacy Protection in Action: TV Advertisement Competition

In an effort to cultivate and foster a culture in which people respect each other's privacy, the PCO jointly organized a "TV Advertisement Competition" with the Hong Kong Federation of Youth Groups targeting participants in the 12 to 34 year age range. To participate, contestants were requested to produce a one-minute TV commercial reflecting their understanding of privacy protection issues that occur in daily life. A series of workshops were also held with the assistance of advertising experts during

which contestants learned about the many aspects and filming techniques involved in producing a television commercial. Entries for the competition will close in April 2003.

暑假巡迴展覽

公署在二零零二年暑期舉辦了一項為期六 週,名為「夏日私隱全面SHOW」的巡迴展 覽,深入社群,直接向市民傳達私隱的訊 息。巡迴展覽內容豐富,包括與個人資料私 隱有關的有趣遊戲、展板及派發宣傳刊物, 讓市民能加深了解保障個人資料私隱的重要 性。展覽的揭幕儀式在七月七日假座銅鑼灣 時代廣場舉行,主禮嘉賓包括灣仔區議會主 席林貝聿嘉太平紳士、民政事務局首席助理 秘書長許鄔芸芸女士,以及著名演員林韋辰 先生及黃德如女士。此外,公署亦在場預播 全新拍攝的培訓影音光碟。於首場展覽後, 巡迴展覽繼而在七月及八月份分別在全港五 個大型商場舉行, 共吸引了超過一萬名市民 參與。

Summer **Vacation Roadshows**

To reach out to members of the general public, the PCO launched a six-week Privacy Summer Roadshow "Privacy Summer Fiesta"



throughout the 2002 summer holidays. The Roadshow featured interesting games on personal data privacy topics, display boards and guidance publications with the aim of raising public awareness of the importance of safeguarding personal data privacy. The event was kicked-off on 7 July at Times Square in Causeway Bay. Guests officiating at the launch included the Chairman of Wan Chai District Council Mrs. Peggy P. Lam, SBS, OBE, JP; Principal Assistant Secretary for the Home Affairs Bureau Mrs. Nancy Hui; and renowned actor and actress Mr. Lam Wai Sun and Ms. Louisa Wong. Members of the public also had the chance to preview the new training video produced by the PCO. After the launch, the

Roadshow toured five major shopping centres in the months of July and August. More than 10,000 visitors were attracted to these events.

Media liaison

In the reporting year, the PCO held three press briefings to announce the consultation exercise on the sharing of positive credit data, the "Privacy Protection in Action: TV Advertisement Competition" and the public consultation report on the sharing

of positive credit data. In addition, the PCO put out seven press releases on various privacy issues and responded to 988 enquiry cases from the media.

在二零零二年八月,公署推出一輯 名為「認識你的個人資料私隱權利」的 全新培訓影音光碟/錄影帶,以活潑生 動的手法介紹私隱條例的規定,並帶出 日常生活中一些保障資料私隱的良好處 事方式。

公署在本年報期內共出版了兩期通訊, 每期發行量超過8,000份,免

費派發給各訂戶、專業團 體、政府部門及其他相關組 織,並以電子形式向超過400 名網上登記訂戶發送通訊。

公署繼續誘過網址 www.pco.org.hk發放私隱 方面的最新消息及活動詳 情,而大部份公署刊物亦 可於公署網址下載。在本 年報期內,公署網址的瀏覽人數高 達131.439人次,即平均 每月為11,000人次。

Publications and Website

In August 2002, the PCO released a new training VCD/ video on the requirements of the PD(P)O. Entitled "Personal Data Privacy and YOU", the video provides lively scenarios that illustrate good data protection practices on various topical privacy issues.

Two issues of the PCO newsletter were published during the year under review. Over 8,000 copies were distributed to subscribers, professional bodies, government

departments and other relevant parties. More than 400 registered online subscribers also received the electronic version of the newsletter via e-mail.

The PCO website at www.pco.org.hk continues to be an effective means for the PCO to disseminate the latest news and activities on privacy

> related matters. Nearly all of the PCO's publications are available for download from the site. During the year under review, the PCO website recorded a total of 131,439 hits with an average of 11,000 hits per month.

保障資料主任聯會

在二零零二至二零零三的會員年度內,聯會 共舉行了兩次全體會議、六次午餐聚會及一 連串的資料保障工作坊。

超過150名會員出席了二零零二年四月十二 日的聯會會議, 並破天荒吸引了超過30名何 東中學公民教育組的成員出席會議。該次會 議的論壇議題是「工作間的僱員監察活動」, 公署榮幸地邀請到香港人力資源管理學會譚 温小雯女士、香港理工大學陳榮照博士,以 及勞工處左陳翠玉女士在百忙中抽空出席是 次會議,並和各與會者分享他們在這方面的 見解。



聯會作了一項新嘗試,在二零零二年六月至 九月期間舉行了六次「午餐聚會」,藉以加強 與會員的溝通。午餐聚會以輕鬆自在的形式 進行。公署以行業性質來把會員分成六組, 讓他們得以和業內人士互相交流意見和心 得,互相借鏡。很高興這項活動得到各會員 的認同,覺得不同機構內負責資料保障工作 的會員可以藉著這些場合建立聯絡網,加強 本身的保障個人資料經驗及知識。

Data Protection Officers' Club

Two plenary Club meetings, six luncheon gatherings and a series of Data Protection Workshops were held during the membership year 2002-03.



Over 150 members participated in the Club meeting held on 12 April 2002 and, for the first time, the event drew the attendance of over 30 members of the Civic Education Committee of the Ho Tung Secondary School. The issue of "employee monitoring in the workplace" was discussed at the Privacy Forum session of the meeting. The PCO were honoured to have Mrs. Monisa Tam of the Hong Kong Institute of Human Resource Management, Dr. Andy

Chan of the Hong Kong Polytechnic University and Mrs. Jennie Chor of the Labour Department to join the meeting and shared their views on the subject.

"Luncheon gatherings" were a new initiative introduced in June to September 2002 that helped to foster communication between

the PCO and members of the Data Protection Officers' Club. The luncheons were held in an informal setting. Members from similar business sectors were



grouped into six separate luncheons so that they could share their work experiences with people in a similar capacity in a relaxing atmosphere. Members in general felt that the luncheons provided them with a platform upon which to build a network with other data protection officers and enhance their work experience and knowledge in personal data protection.

The Privacy Commissioner and other members of the PCO also spoke at a number of local and international conferences on issues related to personal data privacy.
