The Secretary for Home Affairs appoints the Members of the Personal Data (Privacy) Advisory Committee which is chaired by the Privacy Commissioner.

公署組織架構 Staff and Organizational Structure

公署由個人資料私隱專員(下稱「私隱專員」)掌管,負責全面監察和監管私隱條例的施行,並促使各界依從條例的規定。 此外,私隱專員亦負責管理公署的整體行政工作。副個人資料私隱專員在公署的整體行政及策劃方面協助私隱專員,同時亦負責與個人資料私隱有關的各項政策問題。

The PCPD is headed by the Privacy Commissioner for Personal Data ("the Privacy Commissioner") who has overall responsibility for promoting, monitoring and supervising compliance with the Ordinance and administering the activities of the PCPD. A Deputy Privacy Commissioner for Personal Data assists the Privacy Commissioner in the overall administration and strategic planning of the PCPD. She also has responsibility for policy issues relating to personal data privacy.

The following is the organization chart of the PCPD:
