## Personal Data (Privacy) Advisory Committee

Chaired by the Commissioner, the meeting comprises members appointed by the Secretary for Constitutional and Mainland Affairs.

During the reporting period, the Committee held its 26th, 27th and 28th meetings on 10 July 2009, 24 September 2009 and 9 February 2010 respectively. Major agenda items for discussion by members at these meetings covered the legislative amendment proposals included and those not included in the Public Consultation Paper, the amendments of the Memorandum of Administrative Arrangement on overseas duty visits, the recommendations given in the "value-formoney" audit report issued by the Director of Audit and the follow up actions by the Commissioner, the Strategic and Business Plans for PCPD and the risk assessment of the non-compliance with the 45-day requirement under the Ordinance.

公署由私隱專員掌管,負責全面監察和監管 條例的施行,並促使各界依從條例的規定。 此外,私隱專員亦負責管理公署的整體行政 工作。副個人資料私隱專員在公署的整體行 政及策劃方面協助私隱專員,同時亦負責與 個人資料私隱有關的各項政策問題。

在本年報期完結時,公署的職員編制為47 人,分別在七個部門工作。

The PCPD is headed by the Commissioner who has overall responsibility for promoting, monitoring and supervising compliance with the Ordinance and administering the activities of the PCPD. A Deputy Privacy Commissioner for Personal Data assists the Commissioner in the overall administration and strategic planning of the PCPD. She also has responsibility for policy issues relating to personal data privacy.

The PCPD had a total establishment of 47 staff at the end of the period under review and was organized in 7 divisions.
