Communicating Privacy To The Community

公署的其中一項法定職能,是促進各界對條 文的認識和理解,以及遵守條例的規定。為 此,公署舉辦了不同類型的推廣及教育活 動,讓資料當事人明白自己的權利、資料使 用者理解自己的責任。 Promoting the awareness and understanding of the provisions of the Ordinance, as well as the need to comply with them, is a statutory function of the PCPD. Efforts to ensure that data users understand their responsibilities and data subjects understand their rights under the law has seen the PCPD launch an array of promotional and educational activities that continue to draw interest from a wide audience within the community.

Promoting Privacy Rights Among the General Public

2009年的「私隱關注運動」於2009年5月3至9日舉行。踏入第三年,今年的重點在提醒年青人保障個人資料私隱的重要,尤其在使用互聯網的時候。

Privacy Awareness Week 2009

The PCPD continued to join hands with the Asia Pacific Privacy

Authorities (APPA), the principal forum for privacy authorities of Australia, Canada, Hong Kong, New Zealand and South Korea, in organizing the Privacy Awareness Week (PAW). PAW is an annual promotional event that seeks to raise public awareness in the Asia Pacific region of the need for personal data privacy protection.

The third PAW was held during 3-9 May 2009 and focused on reminding young people of the need to protect their personal data privacy, particularly when using the Internet.

Privacy Reports

To draw the attention of young people to the importance of personal data privacy, the PCPD invited representative groups of students from four secondary schools to produce short videos in which they would express their perception about privacy. The videos featured different topics relating to the issue of personal data privacy – security measures relating to smart identity cards, privacy risks arising from social networking websites, the installation of CCTV in public areas and IT security. The project offered the opportunity for the students to broaden their horizon and expose themselves to many privacy experts. PCPD also organized two workshops, one on the protection of personal data privacy and the other on news reporting, for the participating students.







為醫療從業員舉辦「關懷病人保障個人資料」 私隱活動

"Care for Patients - Protect their Personal Data" **Privacy Campaign for Medical Practitioners**

醫療資料包括病人的個人詳情及全部醫療記 錄,屬於高度敏感資料。為保障病人的基本 私隱權,公署與醫院管理局聯合舉辦[關懷 病人 保障個人資料」教育活動,目的是提高 醫管局員工在日常工作中對保障病人私隱的 意識,並教導他們如何採取適當措施,小心 處理病人資料。這是公署第三次為特定行業 舉辦的保障私隱活動。這次,為了配合醫護 人員多元化的工作,公署特地為醫管局員工 設計及提供適當的培訓活動,包括講座、 「私隱資訊站」、展板、宣傳冊、遊戲及小 測驗。



Medical data, which may include patients' personal particulars and their full medical history, is regarded as highly sensitive information. In order to promote the protection of patients' fundamental rights to privacy, an industry-wide educational campaign, "Care for Patients - Protect their Personal Data", was jointly organized by the PCPD and the Hospital Authority (HA). The ultimate goal of the campaign, which was the PCPD's third industry-specific privacy campaign, was to raise HA staff members' awareness of privacy risks in their everyday work and to help them adopt precautionary measures to protect patients' data. To meet the diversified training needs of all HA staff members, the PCPD provided an array of educational activities during the campaign including seminars, "Privacy Desk", display panels, pamphlets, games and quizzes.

在本年報期內,公署接獲502宗傳媒查詢, 較去年多百分之四十六。以下是傳媒查詢的 一些熱門私隱議題:

- 收集指紋資料
- 校園驗毒試行計劃
- 檢討《個人資料(私隱)條例》
- 網上搜尋他人的個人資料

在本年報期內,公署發出了31篇新聞稿,舉 行了四次簡報會及三次記者會。私隱專員及 公署職員就多宗事件對個人資料私隱的影響 接受了21次傳媒的專訪。

Media

The PCPD received 502 media enquiries during the reporting year, a 46% increase from the previous year. The enquiries concerned a range of privacy-related social issues. Some of the significant issues were:

- Collection of fingerprint data
- Trial Scheme on School Drug Testing
- Review of the Personal Data (Privacy) Ordinance
- Searching for personal data of others on the Internet

During the reporting year, the PCPD issued 31 press releases and organized four press briefings and three press conferences. The Commissioner and PCPD staff had 21 media interviews on various issues that impact on personal data privacy.

公署在網頁(www.pcpd.org.hk)上傳遞保障 私隱的訊息。在本年報期內,網頁共錄得 476,249次瀏覽人次,平均每月接近39,687次。

網頁最多人瀏覽的部分是「個案簡述」 (240,006次)及「個人資料(私隱)條例」 (382,587次)。最多人下載的部分是「實務守 則及指引」(101,424次)及查閱資料要求表格 (18,919次)。公署的網頁是公眾查閱公署資 訊及刊物的便捷途徑。

Website

The PCPD continued to disseminate privacy protection messages on its website www.pcpd.org.hk. During the reporting period, the site received 476,249 visits, an average of almost 39,687 visits each month.

Sections that web users visited most frequently were "Case Notes" (240,006 views) and "The Personal Data (Privacy) Ordinance" (382,587 views). The most popular files downloaded by web users were Codes of Practice and Guidelines (101,424 downloads) and Data Access Request Form (18,919 downloads). The high web traffic shows that the PCPD website is a convenient platform for the public to access the PCPD's information and publications.

Promoting Compliance Among Data Users

保障資料主任聯會

保障資料主任聯會(「聯會」)於2000年由公 署成立,讓保障資料主任能夠得悉有關條例 實施的各項議題。聯會更重要的作用是提供 一個途徑讓會員分享有關私隱的良好行事方 式,以及加強與公署的溝通。

聯會成立11年,擁有超過360名來自公私營 機構的會員,包括私隱、循規、法律事務、 規管、執法及客戶關係等範疇。在本年報期 內,公署為聯會會員舉辦了不同類型的活 動,提高他們對資料保障的認識。

全體會員會議

在2009年5月5日,超過120名聯會會員出 席了本年度第一次全體會員會議。公署激請 了澳門特別行政區政府個人資料保護辦公室 主任陳海帆女士講解《個人資料保護法》。此 外,公署職員向會員講解公署最新發表的調 查報告及行政上訴委員會的裁決,讓他們從 中學習條例的詮釋及應用。

Data Protection Officers' Club (DPOC)

Established by the PCPD in 2000, the Data Protection Officers' Club (DPOC) provides members with a platform for networking and the exchange of ideas relating to good privacy practices. As a collective body, the DPOC provides members with an enhanced forum for interaction with the PCPD, thereby enabling them to receive first-hand information about issues relating to the implementation of the Ordinance.

In its 11th membership year, the DPOC has successfully recruited over 360 members. DPOC members include those working in the privacy, compliance, legal affairs, regulatory, law enforcement and customer relations areas within both the public and private sectors in Hong Kong. During the reporting year, various kinds of activities were organized for DPOC members to enhance their knowledge of data protection.

Plenary Meeting

The first plenary meeting held on 5 May was well attended by over 120 members. Ms Sonia Chan, Coordinator of the Office of Personal Data Protection, Government of Macao Special Administrative Region, was invited to speak on the "Personal Data Protection Act". Members were briefed on the latest PCPD investigation reports and decisions of the Administrative Appeals Board, and were able to gain valuable insight into the interpretation and application of Ordinance.



公署在博覽上向 參觀者分發《個人 資料好重要 保障 私隱不可少 - 求職 篇》單張。博覽舉 行期間,公署職員 亦舉辦了題為「如 何在求職時保障個 人資料私隱」的講 座,並即場解答有 關個人資料私隱的 問題。



To convey the relevant messages on the protection of personal data privacy to youngsters and job seekers, the PCPD participated in the "Education & Careers Expo 2010" organized by the Hong Kong Trade Development Council from 4 to 7 February. In particular, job seekers, a group seen to be exposed to the risk of personal data leakage, were reminded not to provide excessive personal data at the recruitment stage and not to hand their personal data to "blind advertisement" advertisers.



A promotional leaflet titled "Personal Data is Essential Protect your Privacy - Job Seeking" was distributed to visitors at the Expo. Staff of the PCPD also delivered a talk on "Protect Job Seekers' Personal Data Privacy" during the fair and provided answers to enquiries relating to personal data privacy.
