### Personal Data (Privacy) Advisory Committee

Section 11(1) of the Ordinance provides for the establishment of the Personal Data (Privacy) Advisory Committee to advise the Commissioner on matters relevant to the privacy of individuals in relation to personal data or the implementation of the Ordinance. The members of the Committee are appointed by the Secretary for Constitutional and Mainland Affairs.

在本年報期間,個人資料(私隱)諮詢委員會分別於2010年7月9日、10月14日及12月30日舉行了第二十九、三十及三十一次會議。會議的主要討論項目包括直接促銷和資料外洩事故管理及通報的指引、《個人信貸資料實務守則》的建議修訂、公署就檢討《個人資料(私隱)條例》向政府提交的意見書,以及處理投訴政策的主要更改。

During the reporting period, the Committee held its 29<sup>th</sup>, 30<sup>th</sup> and 31<sup>st</sup> meetings on 9 July, 14 October and 30 December 2010 respectively. Major agenda items at these meetings included the issue of Guidance Notes on Direct Marketing, as well as Data Breach Management and Notification, proposed amendments to the Code of Practice on Consumer Credit Data, the PCPD's submission to the Government on the review of the Personal Data (Privacy) Ordinance, and major changes in the Complaint-Handling Policy.

在本年報期間,委員會分別於2010年5月25日及12月22日舉行第二及第三次會議。會議的主要討論項目涵蓋Google街景拍攝車輛收集Wi-Fi網絡資料的循規查察、建議中的閉路電視指引、對檢討《個人資料(私隱)條例》的諮詢報告的回應、公眾教育及推廣計劃建議,以及為資料使用者制訂有關資訊科技方面遵守條例的指引。

During the reporting period, the Committee held its 2<sup>nd</sup> and 3<sup>rd</sup> meetings on 25 May 2010 and 22 December 2010 respectively. Major agenda items at these meetings included the compliance check of Google Street View vehicles collecting Wi-Fi data, the proposed CCTV Guidance Note, the PCPD's response to the Consultation Report on the Review of the Personal Data (Privacy) Ordinance, the proposed education and awareness programme for the general public, and the proposed publication of guides on technology related compliance issues for data users.

公署由私隱專員掌管,負責全面監察和監管條 例的施行, 並促使各界依從條例的規定。此 外,私隱專員亦負責管理公署的整體行政工 作。副私隱專員協助私隱專員,負責監督執法 工作,和督導與個人資料私隱有關的政策及科 技議題。首席企業服務經理協助私隱專員在機 構規劃、資源管理、財務、人事行政及辦公室 管理方面提供指導及整體領導。他亦需負責內 部財務和管理的控制及循規事宜。首席律師直 接向私隱專員報告,負責為公署各方面的工作 及執行條例賦予的權力方面提供法律意見及支 援,以及審議政府的條例草案,就當中對私隱 及個人資料保障有影響的事宜,向有關的政策 局提供意見。

在本年報期完結時,公署的職員編制為66人, 分別在十個部門工作(詳見附錄一)。

The PCPD is headed by the Commissioner, who has overall responsibility for promoting, monitoring and supervising compliance with the Ordinance, as well as administering the activities of the PCPD. He is underpinned by the Deputy Privacy Commissioner for Personal Data who oversees the enforcement work and takes care of the responsibility for the policy and technology issues relating to personal data privacy. The Chief Corporate Services Manager assists the Commissioner in providing guidance and overall leadership in corporate planning, resource management, finance, personnel administration and office management. The Chief Legal Counsel, who also reports to the Commissioner directly, provides legal advice and support to the PCPD in the performance of its functions and the exercise of powers under the Ordinance. She also reviews Government bills and provides comments to the relevant policy bureaux on privacy and data protection implications.

The PCPD had a total establishment of 66 staff at the end of the period under review and was organised in seven divisions (see Appendix 1 for more details).
