8 Dec

The Commissioner announced the results of an online survey on how people used social networking sites and other issues in relation to online privacy.

15 Dec

The Commissioner published three investigation reports on the personal data practices of two banks and concluded that the banks had contravened the requirements of the Ordinance for (i) the unauthorised sale of customers' personal data to third parties for direct-marketing purposes, (ii) retention of bankruptcy data for an unjustifiably long period, and (ii) failure to inform customers that some data required to open a savings account was optional.
