私隱之友嘉許獎 Privacy-Friendly Awards

關於「私隱之友嘉許獎」 About Privacy-Friendly Awards

公眾對保障個人資料私隱的期望日漸增加,個人資料私隱專員公署(私隱專員公署)一直倡議機構將保障個人資料私隱作為機構政策和文化的一部分。私隱專員公署於2021年首度舉辦「私隱之友嘉許獎2021」,表揚機構在保障個人資料私隱方面的努力,讓企業、公私營機構和政府部門展示其保障私隱成就。

身處大數據時代,機構妥善處理大量個人資料的最佳方案,是設立完善的個人資料私隱管理系統,並委任保障資料主任,為收集得來的個人資料裝上精密的鎖。突顯機構具備良好數據管治決心,有助增加持份者的信心,贏得聲譽及信任。今屆「私隱之友嘉許獎2023」以「實踐私隱管理系統 建立信任共創雙贏」為主題,藉此鼓勵更多機構支持設立個人資料私隱管理系統的重要性。

With rising public expectations on the protection of privacy relating to personal data, the Office of the Privacy Commissioner for Personal Data (PCPD) has been advocating that organisations should embrace the protection of personal data privacy as part of their organisation policy and culture. In 2021, the PCPD organised the inaugural "Privacy-Friendly Awards 2021" to recognise the efforts made by organisations in protecting personal data privacy, and enable companies, public and private organisations, as well as government departments to showcase their achievements in privacy protection.

In the era of big data, the best way for organisations to properly handle vast amount of personal data is to establish a comprehensive Personal Data Privacy Management Programme and appoint a Data Protection Officer. This is like protecting the data collected under lock. A Personal Data Privacy Management Programme highlights an organisation's commitment to good data governance, which will help increase the confidence and trust of its stakeholders, as well as enhance the organisation's reputation. The PCPD organises the "Privacy-Friendly Awards 2023" under the theme of "Embrace Privacy Management Programme to Gain Trust and Benefits" this year to encourage more organisations to champion the importance of setting up a Personal Data Privacy Management Programme.

嘉許獎級別

Categories of Awards

嘉計獎設有五項「保障私隱措施」。私隱專員公署根據參加機構備有或完成指定的「保障私隱措施」之數目,頒發金、銀、銅三個級別的私隱之友獎項。卓越表現的得獎機構更會獲邀參與推廣活動,展現他們的保障私隱成就。

Five designated "Privacy Protection Measures" are set as goals for organisations to achieve. Depending on the number of "Privacy Protection Measures" that an organisation has put in place or completed, a Gold, Silver or Bronze Privacy-Friendly Award will be awarded to the organisation. Outstanding performers will also be invited to participate in the publicity activities to showcase their achievements in privacy protection.
